We asked him to share his experience of using Xero and his views on the platform. 1. What do you do? I am a Hackathon project manager at the National Hackathon Greece 2017. 2. Describe a typical work day for you, what you do in a day? My work day starts with attending an 8:00 am meeting followed by a meeting with the team and a meeting with the bank to discuss our bank status (i.e. are we approved for the Hackathon and how much money do we have, etc). After that I have a couple of calls with clients and end with my daily tasks which involves designing graphics to be used on the marketing material, designing a trailer for the demo, preparing and adding documentation and speaking with the team regarding the next steps. I am not done yet, I am going over the whole project and then I am ready to start again tomorrow morning. 3. How would you rate your experience of Xero so far? I am a fairly new user and I have used Xero since July 2015. The first couple of years I had a lot of issues but once I had a solid understanding of how Xero works, I find it pretty easy to use and the support is fantastic. 4. How do you manage your business finances? My business finances are managed by a business adviser. He sends me everything that I need and I forward it on to the accountant. 5. Why do you use Xero? I use Xero because I find it very easy to use and I know that I can trust the data. 6. Is there anything you would change about Xero? For the "less experienced users" I believe that there is a lot of information available in the help documentation and in the knowledgebase.
